### The Million Stars Giveaway Official Rules for Partners – Canada

# NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

**1. Eligibility:** The Million Stars Giveaway (the "Sweepstakes") is open only to legal residents of Canada who are at least eighteen (18) years old, who are members of the Starbucks® Rewards loyalty program, and who are employees of Starbucks Coffee Canada, Inc. at the time of entry ("Entrant(s)"). Employees of Merkle Inc., and any of their direct or indirect parent and affiliate companies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all applicable federal, provincial, municipal, territorial, and local laws and regulations and is void where prohibited. For purposes of this Sweepstakes, a "day" begins at 12:00 a.m. PT and ends at 11:59 p.m. PT, except the first day which begins at 4:00 a.m. PT and ends at 11:59 p.m. PT. Administrator's computer is the official time-keeping device for this Sweepstakes.

**4. How to Enter:** During the Promotion Period, visit <u>starbucksstardays.ca</u> ("Promotion Site") and follow the links and instructions to sign into your Starbucks® Rewards loyalty program account ("Account") and register for the Sweepstakes. Once you are registered, there are two (2) ways to earn Sweepstakes entries, as outlined below:

a. Make a Purchase at Starbucks Using a Starbucks Card or linked payment method, or by scanning your Starbucks app prior to checkout: During the Promotion Period, make a qualifying purchase (excluding Starbucks Card and Starbucks Card reloads) at a participating Starbucks retail location in Canada. Then, visit the Promotion Site and sign into your Account and you will have received one (1) entry into the Sweepstakes.

**b.** Enter without Making a Purchase: During the Promotion Period, to enter without making a purchase, visit the Promotion Site and follow the links and instructions to complete and submit the entry form and you will have received one (1) entry into the Sweepstakes.

<u>Limit</u>: Entrant may earn up to two (2) entries per day during the Promotion Period by either making up to two (2) purchase transactions; or up to two (2) "free" requests; or a combination of the purchase and free entry method for a total of two (2) entries per day.

Multiple Entrants are not permitted to share the same email address or Account. Each Entrant is limited to only one (1) Account. Any attempt by any Entrant to obtain more than the stated number of entries by using multiple/different email addresses, Accounts, identities, registrations and logins, or any other methods will void that Entrant's entries and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or entry, the authorized account holder of the Starbucks Rewards Account or email address used to register will be deemed to be the Entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

5. Prize Drawings: Administrator is an independent judging organization whose decisions regarding the administration and selection of potential winners are final and binding in all matters related to the Sweepstakes. Administrator will randomly select the potential Sweepstakes winners from all eligible entries received during the Promotion Period, at 9:00 a.m. PT on October 24, 2022 in Southfield, MI, U.S.A. Potential winners will be notified by email after the date of the random drawing. Potential winners will be required to correctly answer a time-limited skill testing question without any assistance in order to be eligible to receive a prize. If the question is answered incorrectly, the prize will be forfeited. Without limiting the generality of the foregoing, the Sponsor reserves the right, in its sole discretion, to administer an alternate skills testing question as it deems appropriate based on the circumstances, to address disability issues and/or to comply with applicable law. If a potential winner cannot be contacted, fails to correctly answer the time-limited skill testing question, or fails to provide any requested information within the required time period (if applicable), potential winner forfeits the prize. <u>For All Prizes</u>: Each winner will receive an annual form reflecting the taxable value of the prizes redeemed. **7. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of the
