Starbucks Summer Game 2023 Member Game Official Rules - US

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Starbucks Summer Game 2023 (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old and who are members of the Starbucks® Rewards loyalty program at the time of entry ("Entrant(s)"). Employees of Starbucks Corporation, Merkle Inc., and any of their direct or indirect parent and affiliate companies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. The Promotion includes an instant win game ("Instant Win Game") and a sweepstakes ("Sweepstakes"). The Promotion also includes a skill-based game ("Skills Game").

3. Timing: The Promotion begins on May 15, 2023 at 4:00 a.m. Pacific Time ("PT") and ends on June 18, 2023 at 11:59 p.m. PT (the "Promotion Period"). For purposes of this Promotion, a "day" begins at 12:00 a.m. PT and ends at 11:59 p.m. PT, except the first day which begins at 4:00 a.m. PT and ends at 11:59 p.m. PT. For purposes of the Skills Game, a "Week" begins each Monday and ends the following Sunday. Administrator's computer is the official time-keeping device for this Promotion.

4. How to Enter: During the Promotion Period, visit <u>starbuckssummergame.com</u> ("Promotion Site") and sign into your Starbucks Rewards account ("Account"). Each Entrant will receive one (1) game play for registering for the Promotion (first visit only).

Then, there are two (2) ways to earn a game play.

a. Make a Purchase at Starbucks Using a Starbucks Card or linked payment method, or by scanning your Starbucks app prior to checkout: During the Promotion Period, make a qualifying purchase (excluding alcoholic beverages, Starbucks Card and Starbucks Card reloads) at a participating Starbucks retail location in the United States. Then, visit starbuckssummergame.com ("Promotion Site") and sign into your Account and you will have received one (1) game play. Follow the links and instructions to play the game and you will receive either an Instant Win Game prize, one (1) game play, one (1) Sweepstakes entry, or one (1) Skills Game "booster" (awarded at random). If you are a potential winner of a prize, you will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the game.

b. Enter without Making a Purchase: During the Promotion Period, to play without making a purchase, visit <u>starbuckssummergame.com</u> and follow the links and instructions to complete and submit the entry form which includes watching a video and answering polling questions. An email with a unique link will be sent to the email address you provided on the form. Click on the unique link to enter the Promotion Site and sign into your Account and you will have received one (1) game play. Follow the links and instructions to play the game and you will receive either an Instant Win Game prize, one (1) game play, one (1) Sweepstakes entry, or one (1) Skills Game "booster" (awarded at random). If you are a

potential winner of a prize, you will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the game.

<u>Limit</u>: Each Entrant may earn one (1) game play during the Promotion Period for registering for the Promotion; each Entrant may earn up to two (2) game plays per day during the Promotion Period by either making up to two (2) purchase transactions; or up to two (2) "free" requests; or a combination of the purchase and free entry method for a total of two (2) plays per day.

Multiple Entrants are not permitted to share the same email address or Account. Each Entrant is limited to only one (1) Account. Any attempt by any Entrant to obtain more than the stated number of plays by using multiple/different email addresses, Accounts, identities, registrations and logins, or any other methods will void that Entrant's plays and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the Starbucks Rewards Account or email address used to register will be deemed to be the Entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

Bonus Game Plays: During the Promotion Period, each Entrant may receive bonus game plays and Skills Game boosters (which can be used in the Skills Game), as outlined below.

a. Challenges:

<u>Reload your account</u>: During the Promotion Period, add the amount of money as indicated on the Promotion Site to your Account (adding money to a current card or an auto-reload) to receive to receive one (1) bonus play. You will also receive one (1) area clear booster, one (1) object clear booster, one (1) column clear booster, and one (1) row clear booster. Limit: Each Entrant may complete this challenge one (1) time during the Promotion Period.

<u>Order on the app</u>: During the Promotion Period, make as many Mobile Order & Pay purchase transactions as indicated on the Promotion Site at a participating Starbucks store (excluding alcoholic beverages, Starbucks Card and Starbucks Card reloads) to receive one (1) bonus play. You will also receive one (1) area clear booster, one (1) object clear booster, one (1) column clear booster, and one (1) row clear booster. <u>Limit</u>: Each Entrant may complete this challenge one (1) time during the Promotion Period.

<u>Order your faves OR Take a snapshot</u>: During the Promotion Period, depending the specific challenge listed on the Promotion Site, either make as many purchase transactions as indicated on the Promotion Site at a participating Starbucks store (excluding alcoholic beverages, Starbucks Card and Starbucks Card reloads) to receive to receive one (1) bonus play OR play the game five (5) times to receive one (1) bonus play. You will also receive one (1) area clear booster, one (1) object clear booster, one (1) column clear booster, and one (1) row clear booster. <u>Limit</u>: Each Entrant may complete this challenge one (1) time during the Promotion Period.

<u>Redeem Stars</u>: During the Promotion Period, visit a participating Starbucks store and redeem the number of Stars as indicated on the Promotion Site to receive one (1) bonus play. You will also receive one (1) area clear booster, one (1) object clear booster, one (1) column clear booster, and one (1) row clear booster. <u>Limit</u>: Each Entrant may complete this challenge one (1) time during the Promotion Period.

Once each challenge is completed, sign into your Account and follow the links and instructions to "claim" the bonus play and play the game and you will receive either an Instant Win Game prize, one (1) game play, one (1) Sweepstakes entry, or one (1) Skills Game "booster" (awarded at random). If you are a potential winner of a prize, you will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the game.

b. Alternate Method of Entry: To earn bonus game plays and boosters without making a purchase, visit the Promotion Site and follow the links and instructions to select a challenge from the provided list that you would like to earn bonus plays and complete and submit the form, which includes watching a video and answering polling questions, to receive the designated bonus game plays and boosters for the selected challenge. An email with a unique link will be sent to the email address provided on the form. Click on the unique link to enter the Promotion Site and sign into your Account. Follow the links and instructions to "claim" the bonus play and play the game and you will receive either Instant Win Game prize, one (1) game play, one (1) Sweepstakes entry, or one (1) Skills Game "booster" (awarded at random). If you are a potential winner of a prize, you will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the game.

<u>Limit</u>: Each Entrant may receive up to four (4) bonus plays during the Promotion Period regardless of method of entry or combination of method of entry.

5. How to Play the Skills Game: During the Promotion Period, visit the Promotion Site and follow the instructions to click on the "Skills Game" tile. You may view the "onboarding" experience to learn how to play the game. To play the game, when two or more colored bubbles of the same color share a side, tap, or click on any one of these bubbles to clear each of them from the board. When bubbles are cleared, the remaining bubbles collapse down and new bubbles fill in from the top. Each level ("Level") has a limited number of moves in which to complete that Level's goals. If the applicable Level goal is not met before the available moves are exhausted, you must start that Level over again. If there no moves possible because there are not two bubbles of the same color sharing a side anywhere on the game board, the board will clear and randomly refill. There are "boosters" within the game. A booster is an object that triggers a special rule or ability. The boosters are: "area clear," "object clear," "column clear," "row clear," and "skip level." You may earn boosters through the game or by completing challenges, as outlined above in Section 4, or by completing additional challenges, as outlined below. You can use any number of earned boosters during game play.

There are a total of twenty (20) Levels in the Skills Game; three (3) Levels are "unlocked" and available to play at the beginning of each Week. Once you complete a Level, you will not be able to play that Level again. - b. <u>Alternate Method of Entry</u>: To unlock the applicable Week's Expert Mode Level without making a purchase, visit the Promotion Site and follow the links and instructions to select "Expert Mode" from the provided list and complete and submit the form, which includes watching a video and answering polling questions. An email with a unique link

will be sent to the email address provided on the form. Click on the unique link to enter the Promotion Site and sign into your Account to unlock the applicable Week's Expert Mode Level. Once you unlock that Week's Expert Mode Level, you can play it continuously during the applicable Week.

<u>Limit</u>: Each Entrant may unlock the Expert Mode Level one (1) time per Week during the Promotion Period, regardless of method of entry.

During the Promotion Period, in addition to earning boosters through the methods outlined above in Section 4, you may also complete the following non-purchase challenges to earn additional boosters:

<u>Level up:</u> Make your way to chapter 3 of the Skills Game to receive one (1) area clear booster, one (1) object clear booster, one (1) column clear booster, one (1) row clear booster, and one (1) skip the level booster. <u>Limit</u>: You may complete this challenge one (1) time.

<u>Listen to The Starbucks® Daily:</u> Click on "Listen Now" button to receive one (1) area clear booster, one (1) object clear booster, one (1) column clear booster, one (1) row clear booster, and one (1) skip the level booster. <u>Limit</u>: You may complete this challenge one (1) time.

6. Sweepstakes/Instant Win Game Functionality: Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners for each are final and binding in all matters related to the Promotion. For the Sweepstakes: Administrator will randomly select the potential Sweepstakes winners from all eligible entries received during the Promotion Period on or around June 19, 2023. For the Instant Win Game: There will be 10,021,342 random, computer-generated winning times, one for each prize listed below, during the Promotion Period. If you are the first player to play the game at or after one of the randomly generated times, you will be a potential instant winner of the prize indicated. For the Thirteenth Prize, there will be 1,215,000 random, computer-generated winning times from May 15, 2023 at 4:00 a.m. PT and May 21, 2023 at 11:59 p.m. PT; For the Fourteenth Prize, there will be 1,600,000 random, computer-generated winning times from May 15, 2023 at 11:59 p.m. PT and for the Fourteenth Prize, there will be 6,400,000 random, computer-generated winning times from May 21, 2023 at 11:59 p.m. PT and June 18, 2023 at 11:59 p.m. PT.

7. Verification of Sweepstakes and Instant Win Game Winners: All potential winners are subject to verification by Sponsor or Administrator. An Entrant is not a winner of any prize, even if the Instant Win Game or Sweepstakes should so indicate, unless and until Entrant's eligibility and the potential winning play/entry has been verified and Entrant has been notified that verification is complete. 9.
