

## Starbucks Summer Game 2024 Member Game Official Rules - US

**NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

- 1. Eligibility:** Starbucks Summer Game 2024 (the "Promotion") includes the following:
- (A) An instant win game ("Instant Win Game" or "Bubble Pop Game") and a sweepstakes ("Sweepstakes") that randomly award "Prizes and Offers" (see Section 4 for details on the Instant Win Game and Sweepstakes and Section 7 for available Prizes and Offers);
  - (B) A "Puzzle" (see Section 8 for details); and
  - (C) A "Weekly Offer" that is unlocked by making a Qualified Purchase (defined in Section 4). See Section 9 for details.

The Promotion is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old and who are members of the Starbucks® Rewards loyalty program at the time of entry ("Entrant(s)"). Starbucks Partners (employees) are eligible to win Instant Win Game Prizes and Offers and may earn Weekly Offers (see Section 9 below) but are not eligible to win the Sweepstakes Prizes. Employees of Merkle Inc. and any of their direct or indirect parent and affiliate companies, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. Participation constitutes Entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**2. Sponsor:** Starbucks Corporation, 2401 Utah Ave. S, Seattle, WA 98134. **Administrator:** Merkle Inc., 3000 Town Center, Suite 2100, Southfield, MI 48075.

**3. Timing:** The Promotion begins on May 20, 2024 at 4:00 a.m. Pacific Time ("PT") and ends on June 17, 2024 at 11:59 p.m. PT (the "Promotion Period").

- A "Day" begins at 12:00 a.m. PT and ends at 11:59 p.m. PT, except the first day which begins at 4:00 a.m. PT and ends at 11:59 p.m. PT.
- A "Week" begins each Monday and ends the following Sunday, except the last week which starts on Monday, June 10, 2024 and ends on Monday, June 17, 2024.

Administrator's computer is the official time-keeping device for this Promotion.

#### **4. How to Enter for a Chance to Win Prizes and Offers:**

**Register for this Promotion:** During the Promotion Period, visit [starbuckssummertime.com](https://starbuckssummertime.com) ("Promotion Site") and sign into your Starbucks Rewards account ("Account").

**Earn/Receive Instant Win Game Plays:** Entrants can earn/receive Instant Win Game plays (each a "Game Play") throughout the Promotion Period by the methods set forth below. Once earned Game Plays are deposited into Entrant's Account and Entrants can redeem them to play the Instant Win Game at any time during the Promotion Period.

(A) Each Entrant will receive one (1) Game Play deposited into their Account for registering for the Promotion (first visit only) and for logging in on each Friday during the Promotion Period (May 24, 2024, May 31, 2024, June 7, 2024, and June 14, 2024). If you register on a Friday during the Promotion Period, you will receive two (2) Game Plays.

(B) Entrants can earn Daily Game Plays (each Day) by taking the actions outlined below. There are two (2) ways to earn Daily Game Plays.

**(1) Make a Starbucks Purchase Using a payment method linked to your Account (either a registered Starbucks Card or other payment linked method) or by scanning your Starbucks® App prior to checkout:** During the Promotion Period, make any instore Starbucks purchase (excluding alcoholic beverages, Starbucks Card and Starbucks Card reloads) using a Starbucks Card or other payment method linked to your Account in the Mobile App or by scanning your Starbucks App to pay at any participating Starbucks store in the United States (herein a “Qualifying Purchase”). You will receive one (1) Game Play deposited into your Account, except for each Monday during the Promotion Period (May 20, 2024, May 27, 2024, June 3, 2024, June 10, 2024, and June 17, 2024) where you will receive two (2) Game Plays deposited into your Account.

**(2) Enter without Making a Purchase (“Alternate Method Request”):** During the Promotion Period, to receive a Game Play without making a purchase, visit [starbuckssummergame.com](http://starbuckssummergame.com) and follow the links and instructions to complete and submit the entry form which includes providing your first and last name and valid email address associated with your Account and watching a short video and submitting answers to the questions. An email with a unique link will be sent to your Account email address. Click on the unique link to enter the Promotion Site and sign into your Account and you will have received one (1) Game Play deposited into your Account, except for each Monday during the Promotion Period (May 20, 2024, May 27, 2024, June 3, 2024, June 10, 2024, and June 17, 2024) where you will receive two (2) Game Plays deposited into your Account.

Limit: Each Entrant may earn up to two (2) Game Plays per Day during the Promotion Period by either making up to two (2) Qualifying Purchases; or up to two (2) Alternate Method Requests; or any combination of these two methods for a total of two (2) Game Plays per Day. Each Entrant may earn up to four (4) Game Plays each Monday during the Promotion Period by either making up to two (2) Qualifying Purchases; or up to two (2) Alternate Method Requests; or any combination of these two methods for a total of four (4) Game Plays each Monday during the Promotion Period.

**Earn Bonus Game Plays:** During the Promotion Period, each Entrant may receive bonus Game Plays either by completing any of the seven (7) “Activities” listed below or by making an Alternate Method Request (as described above in Section 4(B)(2)) and selecting the particular Activity for which you would like to apply the Alternate Method Request. Entrants may only receive one (1) bonus Game Play for completing each Activity (or by making an Alternate Method Request) during the Promotion Period as outlined below. There is no Alternate Method Request available for Activity 7, as this Activity does not require a purchase.

**(2) Activity 2 – Order on the App:** During the Promotion Period, follow the directions on the Promotion Site to make as many Qualifying Purchases as indicated on the Promotion Site using the Mobile Order & Pay feature of the App to receive one (1) bonus Game Play deposited into your Account.

**(3) Activity 3 – Treat Yourself OR Weekend Vibes:** During the Promotion Period, follow the directions on the Promotion Site to either make:

- (a) the number of Qualifying Purchases on a Saturday or Sunday to receive one (1) bonus Game Play deposited into your Account; OR
- (b) the number of Qualifying Purchases on any day to receive one (1) bonus Game

Play deposited into your Account.

Note: Entrants will only have one of these options available to them during the Promotion Period.

**(4) Activity 4 – Double the Fun:** During the Promotion Period, follow the directions on the Promotion Site to make as many Qualifying Purchases that include at least two (2) handcrafted drinks (ready to drink beverages are not eligible) in one (1) transaction as specified to receive one (1) bonus Game Play deposited into your Account.

**(5) Activity 5 – Afternoon pick-me-up:** During the Promotion Period, follow the directions on the Promotion Site to make as many Qualifying Purchases after 12:00 p.m. local time as specified to receive one (1) bonus Game Play deposited into your Account.

**(6) Activity 6 - Redeem Stars OR Pop the Bubble:** During the Promotion Period, follow the directions on the Promotion Site to either:

(a) Redeem the number of Stars listed as part of an online or instore purchase to receive one (1) bonus Game Play deposited into your Account; OR

(b) Redeem a Game Play earned and play the Instant Win Game/Pop the Bubble Game the number of times listed to receive one (1) bonus Game Play deposited into your Account.

Note: Entrants will only have one of these options available to them during the Promotion Period.

**(7) Activity 7 - Take a Poll:** During the Promotion Period, follow the directions to answer the polling questions on the Promotion Site. By completing the polling questions, you will receive one (1) bonus Game Play deposited into your Account.

**NOTE: Each Qualifying Purchase made during the Promotion Period will automatically be applied (a) to earn a Daily Game Play, (b) towards completing any applicable Activities for Bonus Game Plays, and (c) to unlock the Weekly Offer.**

**Game Play Limits:** Limits for earning/receiving Game Plays are listed above. Multiple Entrants are not permitted to share the same email address or Account. Each Entrant is limited to only one (1) Account. Any attempt by any Entrant to obtain more than the stated number of Game Plays by using multiple/different email addresses, Accounts, identities, registrations and logins, or any other methods will void that Entrant's plays and that Entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, which will be disqualified. In the event of a dispute as to the identity of any entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Promotion and used to enroll in the Starbucks® Rewards loyalty program. If any additional information provided by entrant is inconsistent with the information provided at registration for this Promotion or enrollment into Starbucks® Rewards loyalty program, Sponsor and/or Administrator may disqualify such Entrant and such disqualification may result in the forfeiture of any prizes won. Sponsor, in its discretion, may require additional documentation from entrant to show proof of entrant's identity.

**How to Play the Pop the Bubble Instant Win Game:** Each Game Play earned/received will be deposited into your Account. At any time during the Promotion Period you may sign into your Account and follow the links and instructions to redeem Game Plays to play the Pop the Bubble Instant Win Game. You will receive either an Instant Win Game Prize or Offer (see Section 7), one (1) Sweepstakes entry, or a "Booster" that can be used when playing the Puzzle (awarded at random). If you are a potential winner of a Prize or Offer, you will be provided directions for validation. All potential winners are subject to verification before any Prize or Offer will be awarded. Administrator is responsible for the functionality of the Instant Win Game. *NOTE: Starbucks Partners are not eligible to receive Sweepstakes entries.*

**5. Sweepstakes/Instant Win Game Functionality:** Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of potential winners for each are final and binding in all matters related to the Promotion. For the Sweepstakes: Administrator will randomly select the potential Sweepstakes winners from all eligible entries awarded during the Promotion Period on or around June 18, 2024. For the Instant Win Game: There will be 7,549,900 computer-generated and randomly seeded winning times throughout the Promotion Period for all of the Instant Win Game Prizes and Offers. For the Ninth Prize, there will be 3,000 random, computer-generated winning times from May 20, 2024 at 4:00 a.m. PT and May 26, 2024 at 11:59 p.m. PT; for the Fourteenth Prize, there will be 4,000 random, computer-generated winning times from May 20, 2024 at 4:00 a.m. PT and May 26, 2024 at 11:59 p.m. PT; for the Seventeenth Prize, there will be 325,000 random, computer-generated winning times from May 20, 2024 at 4:00 a.m. PT and May 26, 2024 at 11:59 p.m. PT; for the Seventeenth Prize, there will be 6,295,500 random, computer-generated winning times from May 27, 2024 at 12:00 a.m. PT and June 17, 2024 at 11:59 p.m. PT; for the Eighteenth Offer, there will be 15,000 random, computer-generated winning times from May 20, 2024 at 4:00 a.m. PT and May 26, 2024 at 11:59 p.m. PT; and for the Nineteenth Offer, there will be 255,000 random, computer-generated winning times from May 20, 2024 at 4:00 a.m. PT and May 26, 2024 at 11:59 p.m. PT. If you are the first player to play the game at or after one of the randomly seeded times, you will be a potential instant winner of the Prize or Offer indicated.

**6. Verification of Sweepstakes and Instant Win Game Winners:** All potential winners are subject to verification by Sponsor or Administrator. An Entrant is not a winner of any Prize or Offer, even if the Instant Win Game or Sweepstakes should so indicate, unless and until Entrant's eligibility and the potential winning play/entry has been verified and Entrant has been notified that verification is complete. Sponsor will not accept screen shots or other evidence of winning in lieu of its validation process.
